## What is this product?

### Type

This product is the participating share class issued by the investment fund in the form of a Registered Alternative Investment Fund in Cyprus (Registration no.: RAIF196\_4) and in the legal form of a Variable Capital Investment Company (V.C.I.C.).

### Objectives

**Investment objective:** The aim of the Sub-Fund is to achieve long-term growth through a combination of capital appreciation and regular distribution of income by primarily investing, directly or indirectly, in a broad range of real estate related investments.

**Investment policy:** The Sub-Fund will primarily invest in the commercial real estate sector, while remaining open to opportunities in other sectors, such as residential flats and other property types, if they present strong potential.

The strategy involves direct or indirect investments aimed at acquiring and/or developing various real estate projects that offer superior risk-adjusted returns. Investments may be made directly by the Fund on behalf of the Sub-Fund or through subsidiaries.

The Sub-Fund’s primary target market focus shall be property located in the Central and Eastern European region with a focus on Hungary.

The Sub-Fund will not utilise, either directly or indirectly through its subsidiaries, leverage and borrowings as part of its acquisition program or otherwise.

**Benchmark:** The Sub-Fund is actively managed, meaning the Manager actively selects and invests the securities in which the Sub-Fund invests with the aim of meeting the investment objective of the Sub-Fund and is not managed with reference to a benchmark nor tracks an index.

**Redemption and Dealing:** Following the expiration of the Initial Offer Period, Subscriptions, & Redemptions subject to a 2-year lock-up period, to the Sub-Fund are permissible on the first business day of each calendar semester or any other such period as determined by the AIFM. Subscriptions & Redemptions to the Sub-Fund are subject to a five (5) and sixty (60) day Notice Period, respectively.

The price for the Sub-Fund, reflecting the actual value of the product, is set on a semi-annual basis for the duration of the Sub-Fund, any Subscription or Redemption Date, and the Termination Date as well as the dates mentioned in the Sub-Fund’s annual and half-yearly reports.

**Distribution policy:** This is the only investment participating share class of the Sub-Fund. The Shares carry the right to dividends and/or other distributions from the profits of the Sub-Fund, at the discretion of the Manager.

**Conversion of shares:** The Shares are not exchangeable with shares of other Sub-Funds by option of the Investor. The Sub-Fund has not issued any other share class other than the Shares.

**Launch:** The Sub-Fund came into existence in 2025.

### Intended retail investor

The product is intended to be marketed and only suitable to professional and/or well-informed investors that qualify as having sufficient experience and theoretical knowledge of financial and business matters in general, can bear the loss of their entire investment and who fully understand and are willing to assume the risks involved in such an investment program. **This product is not simple and may be difficult to understand.**

This product is intended for investors who plan to stay invested for at least 2-4 years and are prepared to take on a high level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

### Term

This product is an open-ended fund with no defined term nor maturity date, subject to a two (2) year lock-up period. Subject to the liquidation, dissolution and termination rights of the board of the Fund, as set forth in the Fund’s Prospectus, the Sub-Fund cannot be automatically terminated. The manufacturer is not entitled to terminate the product unilaterally.

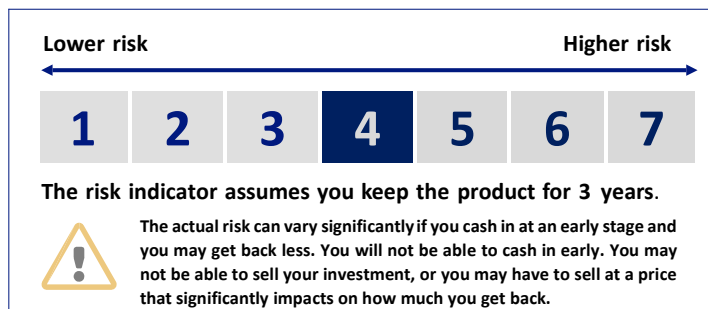

## What are the risks and what could I get in return?

### Risks

We have classified this product as 4 out of 7, which is a medium risk class. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the

### Past Performance

## What are the costs?

### Recommended Holding Period: 3 years

The price for the Sub-Fund, reflecting the actual value of the product, is set on a semi-annual basis following the expiration of the Initial Offer Period, any Subscription or Redemption Date, and the Termination Date as well as the dates mentioned in the Sub-Fund's annual and half-yearly reports.
